# The Maine Trust for People with Disabilities (MTPD)

A pooled trust used for the supplemental needs of individuals with intellectual and developmental disabilities or acquired brain injury

## Benefits of an account with the Maine Trust for People with Disabilities

### THE MTPD MAY BE USED FOR:

- RECREATION
- TRAINING/EDUCATION
- A VEHICLE
- ELECTRONIC DEVICES
- APPLIANCES
- MEDICAL CARE AND GOODS NOT COVERED BY MEDICAID
- OTHER LIVING EXPENSES NOT COVERED BY PUBLIC BENEFITS

### LOWER COST

The MTPD offers a low-cost option to establish a special needs trust account for a person with disabilities. In fact, an MTPD account typically costs a fraction of the expense of having a lawyer set up an equivalent trust that is run by a bank.

### PERMANENCY

The MTPD is sponsored and run by a Maine nonprofit corporation known as the Maine Trust for People With Disabilities, Inc., a permanent entity established as a 501(c)3.

### KNOWLEDGE

The MTPD has a detailed knowledge of the eligibility requirements of the government programs that disabled beneficiaries rely on for daily support, especially SSI and Medicaid. This allows the MTPD to make distributions that do not jeopardize an individual's Medicaid, SSI or other public benefits.

### COMMITMENT

The MTPD draws volunteers from a wide range of disciplines, including social service agencies, law, business, accounting, finance, banking, etc. Most members of the Trust's Board of Directors either have family members who have a disability or are professionals who work with people who have an intellectual disability. All have long-standing personal commitments to improve the lives of Mainers with disabilities.

## Who we are

The MTPD is sponsored by a Maine nonprofit corporation. The daily operations of the Trust are performed by a wide range of volunteers, including people who have disabled family members, representatives of social service agencies, and individuals from the legal, business, accounting and investment management business. Norway Savings Bank serves as Trustee, and Old Port Pension Administrators is the recordkeeper.
